# ADMISSION OF NEW MEMBERS

## Instructions to Proposers and Seconders

- (a) The Proposer and Seconder shall have been Full, Country, Regional or Life members of the Cruising Yacht Club of Australia for at least one year, and shall have personally known the candidate for not less than one year.
- (b) The candidate should be well known to both the Proposer and Seconder. Casual acquaintance is not sufficient.
- (c) The Proposer and Seconder should be certain that the candidate has the necessary qualifications for membership. Considerations of expediency, business, political, religious or personal obligations must play no part, but rather the test "Is this candidate the type of person whom I should be glad to welcome regularly into my home?" should be applied.
- (d) It is Club policy that persons nominated for membership should show evidence of active interest or participation in yachting.

### Procedure for Nomination of Members *(CYCA By-Law Section 2, No:2)*

**NB: Entrance fee and passport sized photograph of applicant must accompany nomination form. Please note the entrance fee is non-refundable. All details must be supplied prior to presentation to the Board for consideration of the membership application.**

- (a) Completed nominations for membership are tabled before the Board for consideration.
- (b) Following consideration by the Board, the names and addresses of the candidates, together with the names of Proposers and Seconders, are posted on the Notice Board of the Club for not less than 21 days. Once the required display period is over, the nomination will be presented to a further Board meeting for final approval.
- (c) When a candidate has been accepted for membership, the Secretary shall give written advice, and render an account for the first Annual Subscription. Payment must be made within two months to commence membership.
- (d) At any stage prior to election, an application may be deferred or rejected. No reasons will be given for such decision. An application may be withdrawn by the Proposer, Seconder or applicant at any time.
